# MARIJUANA LEGALIZATION

marijuana issues moving forward the Ohio Attorney General's Office, the Governor's Office, Prosecutor Office and the courts to determine how we handle there are multiple outstanding legal questions that have yet to be answered. So, we are patiently awaiting guidance from Since the passage of Issue 2 in the most recent election, Chief Motter has been asked multiple times about the Waynesfield Police Department's response to the legalization of recreational use of marijuana. While the issue did pass,

but the issue is likely only going to worsen. We are also going to see issues with people growing marijuana for personal use, then turning around and selling it for profit. We are also being warned by our colleagues from states that have already issues such as driving while impaired or under the influence of marijuana has been a problem for several years already, legalized recreational marijuana that juvenile consumption issues will likely increase as well.

There is no clear-cut direction on how this is going to be handled as other states are struggling with similar problems, so we are very much in a "wait and see what happens" position at the current time.

### DRUG ISSUES

Aside from the marijuana issue, we have started to see an increase in other drug issues, specifically drug overdoses, in the area. The main drug seems to be fentanyl use. Just this past weekend, the village had an overdose. That marks the 3rd resident in the last couple months that we know has had a suspected drug overdose. Just so council is aware, we do have Narcan in our cruisers that we obtained for free from the Allen County Health Department. They provide first responders with free Narcan through a grant offered by the State of Ohio.

#### Electric

AMP was called in to fix the service. Village A resident had a tree trimmed, while being done a branch fell on the neighbor's electrical service. ### Water and Sewer

A water leak on W. Wapak Street was discovered after finding chlorinated water in the storm drain. A leak detection company was called in and leak was pinpointed in the road. Upon excavation it was found that a gasket in the 12" main was bad due to improper installation. All work and leak detection will be covered under warranty. Administrator Bender will be talking with the engineer as to covering water loss cost.

The Village of Waynesfield is still waiting for the radio portion of the meters to come in so that meters can start being installed.
