# **RESOLUTION 24-3-2**

# APPROVING AND AUTHORIZING THE EXECUTION OF THE MATERIALS LICENSE AGREEMENT BETWEEN ARROW INTERNATIONAL MEDIA LTD. AND THE VILLAGE OF WAYNESFIELD, OHIO AND DECLARING AN EMERGENCY

WHEREAS, the Village Chief has been contacted by Arrow International Media Ltd. regarding its desire to receive certain public records, namely body-cam footage and related documents surrounding a high speed chase to use for television production, working title (subject to change), "High Speed Chase Series 2; and

WHEREAS, the television production is a true crime documentary series produced for the US channel Investigation Discovery which shines the spotlight on the most compelling police pursuits across America, caught on camera, and featuring real testimony from the officers involved.

NOW, THEREFORE, THE VILLAGE OF WAYNESFIELD HEREBY RESOLVES as follows:

SECTION I. While a License Agreement is not necessary, as the requested records are public records, the Village desires to enter into the Materials License Agreement, attached as Exhibit A, as Arrow International Media Ltd. has a stated business practice of requesting execution of the agreements in advance of production.

SECTION II. Execution of the Materials License Agreement will shine light on the exceptionally police work performed by the Village Police Department to a national audience.

SECTION III. All required Village officials are hereby authorized to execute the Materials License Agreement, attached as Exhibit A, including the Mayor, Clerk and Solicitor, a great and solicitor of the second s

In exchange for good and valuable consideration (receipt and sufficiency of which is acknowledged), including the opportunity for the Material to appear in the Program, it is agreed as follows:

You hereby grant to Licensee the non-exclusive and irrevocable right, but not the obligation, to use all or any part of the Material solely in connection with the Program (as defined above), without restriction, in any media whatsoever (the "Media"), throughout the world, in perpetuity. You permit Licensee to record, copy, cut, manipulate, edit, dub, subtitle, reproduce, broadcast, transmit and perform all the Material in connection with the production, exploitation, promotion or/and advertising of the Program as required and all extensions and renewals thereof by all means and in all Media.

Licensee acknowledges that You shall remain the exclusive owner of the Material and all rights not expressly granted to Licensee hereunder are reserved to Licensor.

You acknowledge that the Licensee shall be the exclusive owner of all rights in the Program and that the Licensee shall have the right to assign or license those rights without restriction.

You warrant that you are the sole owner of all rights in the Material and have the sole right and authority to grant this permission and that the Licensee may use the Material without further payment to, or being in violation of the rights of, any other third party. Further, Licensor shall not be entitled to seek any injunctive or equitable relief in connection with any breach or alleged breach of this Agreement, and Licensor's only remedy in the event of a breach shall be to seek damages.

You understand that Licensee is not obligated to include the Material in the Program.

This Agreement constitutes the final and entire agreement between the parties. This Agreement shall be governed by and construed under the laws of New York State.
