THEREFORE, BE IT RESOLVED by the Council of the Village of Waynesfield, County of Auglaize, State of Ohio, to approve the agreement for part-time school resource officer services between the Village of Waynesfield and the Waynesfield-Goshen Local School District for the 2024-2025 school year.
