

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR AND STAFF  
TO EXECUTE AND ADOPT ANTHEM HEALTH PLAN  
SOCA BENEFIT PLAN BLUE ACCESS PPO 6350E/0%/6350 W/HSA-8BUB WITH  
OHIO INSURED SERVICES FOR THE  
VILLAGE OF WAYNESFIELD AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Waynesfield currently receives health insurance coverage through Ohio Insured Insurances; and

WHEREAS, the current health insurance plan the Village carries is eligible for renewal; and

WHEREAS, the Village desires to continue to contract for similar benefits for its employees.

THEREFORE, BE IT ORDAINED, that:

SECTION 1: The Village chooses a plan that is the most comparative to the current plan.

SECTION 2: The Village authorizes its Administrator and Fiscal Officer to execute all necessary documents to bind the renewal plan, the application with Ohio Insured Services (part of the Ohio Public Entity Consortium), for renewal and the new insurance plan will be SOCA Benefit Plan Blue Access PPO 6350E/0%/6350 w/ HSA-8BUB, and will go into effect as of May 1<sup>st</sup>, 2025.

SECTION 3: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.

SECTION V: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety in the Village of Waynesfield, for the reason that it desires to continue to provide health insurance benefits for its municipal workforce, therefore, this Ordinance shall be in effect if it receives two thirds vote of all members of Village Council on the earliest date allowed by law.
