A RESOLUTION DESIGNATING THE WAYNESFIELD PARK TO "THE WAYNESFIELD VETERANS MEMORIAL PARK"

WHEREAS, the Village of Waynesfield owns that certain park property located at 1 Park Drive, Waynesfield, OH 45896 (hereinafter the "Park:"), and

WHEREAS, the Park currently has no formal name other than the Waynesfield Park; and

WHEREAS, the Village Council in support of the veterans serving the United States of America, past, present, and future, with specific emphasis on those veterans from the Village of Waynesfield does desire to honor said veterans; and

WHEREAS, the Council believes it is in the best interest of the citizens of the Village of Waynesfield and the Village of Waynesfield to designate the Park in honor of said veterans;

NOW THEREFORE, BE IT RESOLVED, BY THE COUNCIL OF THE VILLAGE OF WAYNESFIELD, AUGLAIZE COUNTY, OHIO, AT LEAST A MAJORITY THEROF CONCURRING THAT:

Section 1. The Park located at 1 Park Drive, Waynesfield, OH 45896 shall hereby be designated as The Waynesfield Veterans Memorial Park.

Section 2. The Waynesfield Veterans Memorial Park shall be dedicated to honor the veterans serving the United States, past, present, and future, with special honorific to those veterans who live, have lived, or will live in the Village of Waynesfield.

Section 3. The Village Administrator is hereby authorized to take all steps necessary to effectuate this Resolution.

Section 4. That all resolutions inconsistent with this Resolution be, and the same hereby are, repealed.

Section 5: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.

BE IT FURTHER ORDAINED that this Resolution shall be in full force and effect from the earliest period allowed by law.
