

**ORDINANCE 2025-7-3**

**AN ORDINANCE TO AMEND ORDINANCE 24-10-1 TO AMEND THE ANNUAL APPROPRIATIONS ORDINANCE AND TO DECLARE AN EMERGENCY**

WHEREAS, the Council of the Village of Waynesfield, Ohio has reviewed the Annual Appropriations Ordinance and has determined it is necessary to amend certain fund account totals to reflect the actual amounts to be appropriated.

WHEREAS, the Council of the Village of Waynesfield, Ohio believes that it is necessary to make the amendment of appropriations as an emergency measure to provide uninterrupted funding to the Village of Waynesfield Police Department in order to protect the public health, safety, and welfare of the Village and its residents.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Waynesfield, Ohio:

SECTION 2. Existing Ordinance 2024-10-1 is hereby amended and restated.

SECTION 3. The Fiscal Officer is hereby authorized to make payments from any of the appropriations herein made, upon receiving proper claims, certificates and / or vouchers approved by the officials, department heads, or their respective designees, authorized by law to approve the same, or upon an ordinance or resolution of Council to make expenditures, provided, however, that no payments for salaries or wages shall be made except to persons employed in accordance with the ordinances of the Village of Waynesfield and / or laws of the State of Ohio.

SECTION 4. The Fiscal Officer is hereby authorized to adjust appropriations within any fund or department, so long as the adjustments made do not exceed the total appropriations authorized within any fund or department. In addition, the Fiscal Officer is hereby authorized to establish additional accounts within any fund as may from time to time be required to ensure proper accounting or by the State of Ohio.

SECTION 5. Severability and Repealer.

If any provision or portion of a provision of this Resolution are held to be unconstitutional, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the Resolution shall not be invalidated.

All Resolutions or parts of Resolutions, which are inconsistent with any provisions of this Resolution, are hereby repealed as to the extent of such inconsistencies.

SECTION 6. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements.

SECTION 7. Notice

The Clerk shall cause a copy of this Resolution to be posted in a manner consistent with Ohio Law.

SECTION 8. This ordinance is declared to be an emergency in order to provide uninterrupted funding to the Village of Waynesfield Police Department in order to protect the health, safety, and welfare of the Village of Waynesfield and its residents, and therefore take effect and be in full force immediately upon its passage and approval.
