July 28, 2025

- 1. The meeting was called to order on July 28, 2025, at 6:30 P.M. with the following answering Roll Call: Mayor Luma; present; Fox, absent; Ball, present; Hutson, present; Nickles, present; Miller, present; Walti, present.
- 2. The Minutes of the previous meeting were read and approved.
- 3. Fiscal Officer reported \$1,767,954.01 in all funds. \$369,043.07 in the General Fund.

Craig Mescher attended the meeting and went over the East Wapakoneta Street Funding. He stated that Ohio St and Cook St have OPWC paperwork in and those streets will not be on this project. He also stated that OWDA water and wastewater loans can only come out of the water and sewer funds.

Administrator Bender asked about the CBDG Grant. Mr. Mescher stated that the village does not qualify for grants due to the Village's water and sewer rates. They are too low to be considered for those Grants.

7. POLICE REPORTS:

ZONING AND PROPERTY MAINTENANCE ISSUES

Chief Motter reported that the Zoning Board of Appeals met on July 15, 2025, to receive training/guidance/legal counsel from our Solicitor Daniel Bey. Solicitor Bey had some concerns that will need to be addressed moving forward. He said he would be making recommendations to council in the future.

Chief Motter did advise that the properties that were previously slated for abatement were cleaned up and the solicitor was fine with it.

SUMMER ISSUES

Chief Motter reported that in addition to all of the code enforcement issues he's been handling, a number of criminal matters have surfaced. Illegal drug use, domestic violence, internet/phone scams, and civil issues have topped the list of complaints he's handled and/or are currently investigating. The Sheriff's Office has also been busy in town with investigations on elder abuse, internet/phone scams, and civil complaints. All of these calls are fairly typical for the time of year. Though, some of these investigations take time to work through and must be prioritized over other matters, such as code enforcement.

There has also been a spike in citizen conversations. These are typically good encounters where people are asking questions about the community happenings, providing information/intelligence on issues within their neighborhood, etc. This is normal during the summer as more people are outside and can easily have those conversations. Chief Motter said this is very good that the public wants to interact with the police department as it builds a positive rapport between the community, village and police department.

8. VILLAGE ADMINISTRATOR REPORT:

Water and Sewer

Administrator Bender state the Village will need to pass two resolutions for funding thru OWDA for E. Wapakoneta Street. Access Engineering will be at the meeting to update council.

The East Wapak project will be starting to Mobilize equipment the last week of July. Administrator Bender met with engineers last week on project changes, they will be getting updated numbers to us.

Administrator Bender stated the Village has been working with Ohio Rural Water to have a rate study done for the water and sewer rates in 2026.

Park

The council will have an Ordinance for the Nature Works Grant and one for raising the bonding for the fiscal officer until the project is completed.

9. MAYOR'S REPORT:

a. Mayor's Court Report- \$222.00 was deposited in the General Fund from the Mayor's Court Account for the month of June.

10. OLD BUSINESS:

Code Enforcement (Police Dept.)

Chief Motter stated that two of three properties that were abated had residents living in them. The residents did ask during the clean up process how much the cost would be. Chief Motter stated he informed them they would receive a bill an then would have 30 days to pay it.

Chief Motter provided before and after pictures to the council. He stated that from the time of the first notice to when the cleanup was completed, the process took 10-20 hours per property and approximately 3 to 4 months.

Councilmember Nickles thanked Chief Motter for his work. Chief Motter stated activity breeds activity and, by setting that precedent, we are on the right path for keeping the community clean.
